From April 1, 2018 to March 31, 2019 the BCAPOP Board of Directors has worked with the Executive Director and Administrative Coordinator and:

- Identified BCAPOP's needs for a new Executive Director after Anne Guarasci, BCAPOP's Executive Director resigned on May 31, 2018
- Welcomed one new Board Member: Meaghan Brister at the 2018 AGM
- Recruited, hired and trained our Executive Director, Heather Cameron RN, on November 1, 2018.
- Identified BCAPOP Member Program needs through a member survey and explored funding options to meet those needs
- Secured funding through the Public Health Agency of Canada to initiate the creation of the BCAPOP
 Pregnancy Outreach Program Handbook, which was identified as a need in the member survey
- Altered the format of Monthly General Member Meetings to provide updates from stakeholders and community professional speakers in response to the member survey results
- Initiated the process of applying for charitable status for BCAPOP
- Offered and completed the 2018-19 BCAPOP Nutrition Program, funded by the Public Health Agency of Canada and in partnership with Vitamin Angels and Natural Factors
- Planned and delivered our 22nd Annual BCAPOP conference in October of 2018; 118 pregnancy outreach program staff, stakeholders, and other professionals attended to network, learn and disseminate knowledge back to their programs and communities

Looking forward from April 1, 2019 onward:

- Completed a new BCAPOP Strategic Plan in April 2019 that guides the work of the organization
- Created and implemented a budget for 2019-20, while implementing new financial policies and procedures as of April 2019 in order to achieve long-term financial sustainability of BCAPOP
- Secured Provincial funding from PHSA and initiated the BCAPOP Perinatal Substance Use Project in April 2019
- Administrative Coordinator, Barbara Bremmer resigned as of July 30, 2019
- Recruited, hired and trained a new Administrative Coordinator, Monica Fitzpatrick, as of August 1, 2019
- Completed the BCAPOP Pregnancy Outreach Program Handbook and disseminated to all BCAPOP
 Member Programs and Canadian Prenatal Nutrition Programs free of charge in August of 2019
- Diligently worked to attract new BCAPOP Program and Associate Members Programs to strengthen BCAPOP

Treasurer's Report

April 1, 2018 - March 31, 2019

The following is a summary from the Notice to Reader prepared by Matilda D'Silva, CGA, in Burn's Lake, BC, for BCAPOP.

Total Revenue for 2018-19 was \$115,657

Revenue Sources for 2018-19

MEMBERSHIPS

BCAPOP had a total of 54 members and 2 associate members this year with a total revenue of \$14,678.

CONFERENCE

BCAPOP hosted a successful 22nd Annual Conference at the Vancouver Airport Westin Hotel, with the theme "Exploring Mental Health: Well-being for Infants, Parents and Support Workers." The Conference was held Oct 3 - 5, 2018 and featured keynote speaker Dr. Vanessa Lapointe. BCAPOP also hosted a 2-day Breastfeeding Support Training pre-conference session, delivered by Marianne Brophy, an International Board-Certified Lactation Consultant and educator. Conference registrations totaled \$61,882 (including \$9575 pre-conference revenue).

NUTRITION SUPPORT

Public Health Agency of Canada provided BCAPOP with \$33,250 to improve access to nutritional supports for participants in off-reserve Canada Prenatal Nutrition Programs (CPNP) and BCAPOP full voting member programs. The USA based organization Vitamin Angels provided 2898 bottles of prenatal vitamins free of charge, once again, allowing for funding to purchase Vitamin D (\$7,697) and additional funding to be allocated to 56 programs. These funds were prorated based on the number of prenatal intakes. A total of \$19,319 was disbursed to programs for the purchase of food vouchers, fresh produce hampers, and/or to support community kitchens/gardens.

BCAPOP HANDBOOK PROJECT

The Public Health Agency of Canada provided a grant of **\$5000** and support to create, edit and disseminate a BCAPOP Pregnancy Outreach Program Handbook in response to requests from pregnancy outreach programs for many years.

Total Expenses for 2018-19 were \$121,510

OPERATIONAL COSTS

Total operational costs for 2018-19 were **\$58,588** including advertising, bookkeeping, accountant, insurance, office supplies, postage, contractor fees, bank fees, teleconferencing, board and contractor travel and handbook project expenses.

CONFERENCE

Costs for the 2018-19 conference were **\$34,032** including audio visual costs, pre-conference costs, food & beverages and speaker fees.

NUTRITION SUPPORT

Total nutrition support was \$28,890 including vitamin D costs, vitamin shipment costs and program funding.

Net Assets as of March 31, 2019: \$38,225

Year Ended March 31, 2019

The BC Association of Pregnancy Outreach Programs (BCAPOP) was incorporated under the laws of the Province of British Columbia on March 12, 1996. It is a member driven non-profit society, representing over 50 Pregnancy outreach programs throughout the province of British Columbia (BC). Pregnancy outreach programs (POP) provide pregnancy and early parenting support to women and their families who experience health or lifestyle changes during pregnancy, birth and the transition to parenting. BCAPOP membership provides networking and mentorship opportunities with pregnancy outreach programs throughout BC. In addition, the organization hosts a conference in Vancouver every year to support POP staff professional development.
